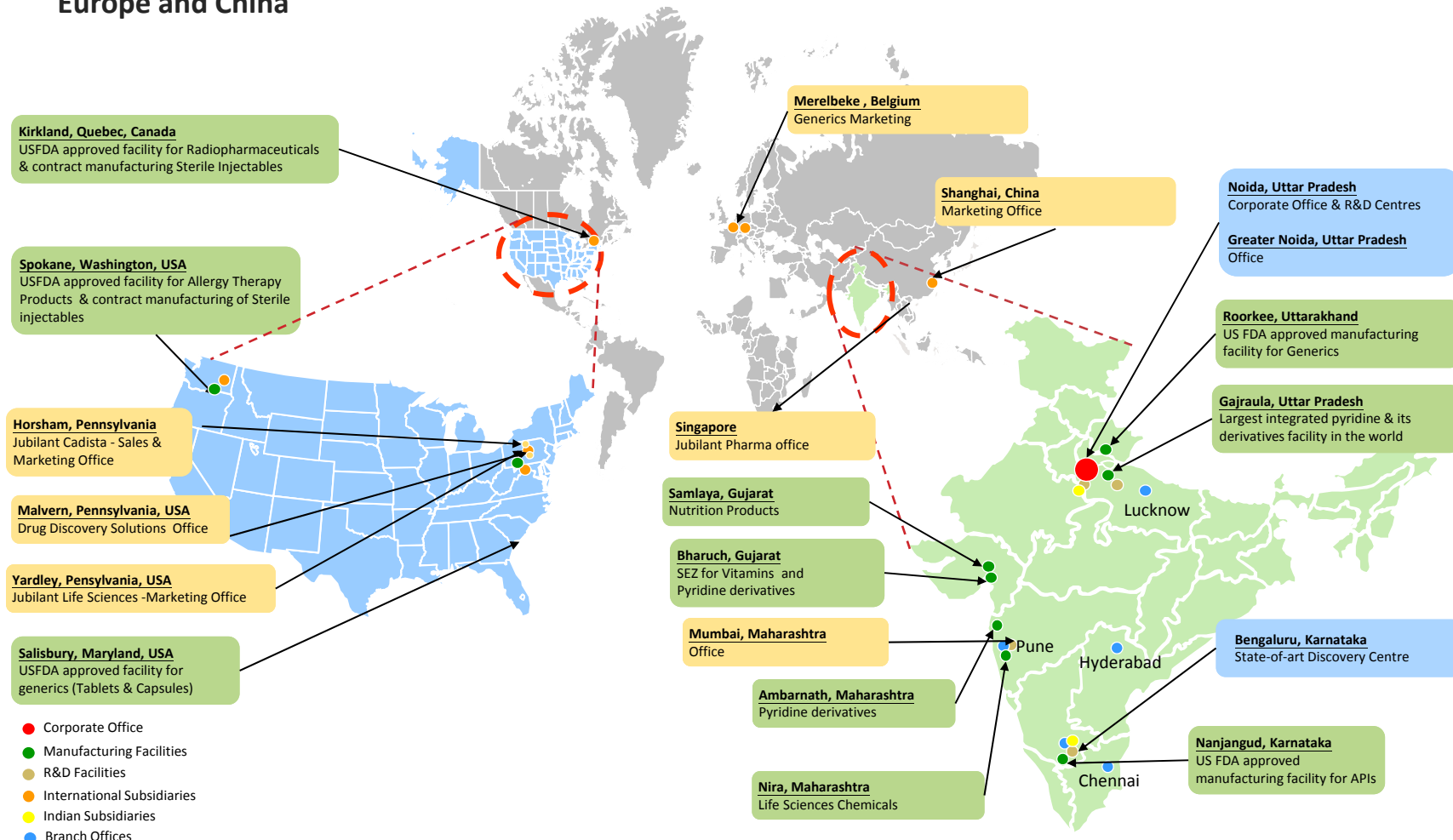


Global Presence
